



## SCCM SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. **PROMOTION DESCRIPTION.** The SCCM Sweepstakes (“Sweepstakes”) begins on Sunday, February 17, 2019, at 9:30 a.m. Pacific Time, and ends on Tuesday, February 19, 2019, at 1:30 p.m. Pacific Time (the “Promotion Period”).

The sponsor of this Sweepstakes is the Society of Critical Care Medicine, a California nonprofit corporation (“Sponsor”). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission, and processing of entries and the overall administration of the Sweepstakes. 2. **ELIGIBILITY.** Open to registrants of the 48th Annual Critical Care Congress in San Diego, California, USA, who are at least eighteen (18) years old. (the “Entrant”). Sponsor, and its respective affiliates, including but not limited to, its contractors and each of their respective officers, directors, and employees (the “Promotion Entities”), are ineligible to enter the Sweepstakes or win a prize.
