SCCM DRAWING OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. INTERNET ACCESS, VALID EMAIL ADDRESS, AND POSTAL MAILING ADDRESS REQUIRED.

- 1. DESCRIPTION. The SCCM Drawings ("Drawings") begin on Sunday, January 21, 2024, at 8:00 a.m. Mountain Time, and end on Tuesday, January 23, 2024, at 11:59 p.m. Mountain Time (the "Period").
 - The sponsor of these Drawings is the Society of Critical Care Medicine (SCCM), a California nonprofit corporation ("Sponsor"). By participating in the Drawings, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission, and processing of entries and the overall administration of the Drawings. Entrants should look solely to Sponsor with any questions, comments, or problems related to the Drawings. Sponsor may be reached by email at suppport@sccm.org during the Period.
- 2. ELIGIBILITY. Open to registrants of the 2024 Critical Care Congress in Phoenix, Arizona, USA, who are at least eighteen (18) years old ("Entrant"). Sponsor, and its respective affiliates, including but not limited to its contractors and each of their respective officers, directors, and employees ("Promotion Entities"), are ineligible to enter the Drawings or win a prize. Household Members and Immediate Family Members of such individuals are also ineligible to enter or win. "Household Members" shall mean those people who share the same residence at least three months a year. "Immediate Family Members" shall mean parents, stepparents, legal guardians, children, stepchildren, siblings, stepsiblings, or spouses. Only one prize per person and per household will be awarded. Prizes cannot be transferred, redeemed for cash, or substituted by the winner. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The ARV of the prize represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the prize turns out to be less than

the stated ARV, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the appearance, safety, or performance of any prize awarded. Restrictions, conditions, and limitations may apply. Sponsor will not replace any lost or stolen prize items.

4. HOW TO ENTER. Entrants enter each Drawing during the Promotion Period by visiting SCCM Central in the Connections Central (Exhibit Hall) and having their show badge scanned. Final eligibility for the awarding of any prize is subject to eligibility verification as set forth below. All entries must be submitted by the end of the Promotion Period in order to participate.

- a. SCCM Central Drawing. The Winner(s) of the Apple Watch Drawing(s) will be selected in a random drawing from among all eligible entries received throughout the Promotion Period. The five (5) drawings will take place during the Promotion Period where the individual whose name is drawn must be there to claim the prize.
